ALL PEOPLE ATTENDING THE SHOW inc. EXHIBITORS, JUDGES, COMMITTEE MEMBERS

KC RULES BUT BOTH PARTIES ARE ADVISED TO USE ANTI-BACTERIAL HAND GEL IN BETWEEN AWARDED THE CERTIFICATES AND MASK.

THERE WILL BE NO TROPHIES AWARDED AT THIS SHOW. THOSE WHO CURRENTLY HOLD THE TROPHIES AWARDED AT 2019 CHAMP SHOW ARE ASKED TO KEEP THEM UNTIL SUCH TIME THEY CAN BE RETURNED TO THE TROPHY STEWARD (MANDY BOAZ).

EXHIBITORS

TO BRING OWN MASK, GLOVES, ANTI-BACTERIAL HAND GEL, AND ANTI-BACTERIAL WIPES.

ALSO ADVISE TO BRING OWN CHAIRS.

RING NUMBERS TO BE LAID OUT AND COLLECTED FROM TABLE. EXHIBITORS WILL BE ADVISED TO ONLY COLLECT THEIR NUMBER AND NOT TOUCH ANY OTHER NUMBERS ON THE TABLE.

EXHIBITORS WILL BE REQUIRED TO KEEP AT LEAST 1 METRE PART IN THE RING, AND ADVISED NOT TO WAIT AT THE ENTRANCE OR EXIT OF THE RING PRIOR TO THEIR CLASS BEING CALLED. THE RING WILL BE CLEARED IN BETWEEN CLASSES PRIOR TO THE NEXT CLASS BEING CALLED.

THOSE EXHIBITORS WISHING TO WAIT IN THEIR CARS, THE STEWARDS WILL ENSURE THAT EACH CLASS IS CLEARLY CALLED INSIDE AND OUTSIDE THE VENUE.

WITHIN THE HALL EXHIBITORS WILL BE ABLE TO BRING CRATES IN THE HALL, AND WILL BE ALLOCATED AN AREA TO SET-UP CHAIRS ETC. THERE WILL BE AT LEAST 1 METRE BETWEEN EACH DESIGNATED AREA.

ALL PEOPLE ATTENDING THE SHOW inc. EXHIBITORS, JUDGES, COMMITTEE MEMBERS

EXHIBITORS WILL NOT BE ABLE TO SIT RINGSIDE, AND WILL BE REQUESTED TO STAY IN THEIR ALLOCATED AREA.

EXHIBITORS WILL BE ASKED TO KEEP MOVEMENT AROUND THE VENUE TO A MINIMUM WHERE POSSIBLE.

EXHIBITORS TO BE ADVISED BRINGING ADDITIONAL FAMILY MEMBERS TO A MINIMUM.

OFFICERS & COMMITTEE

MASKS, GLOVES, ANTI-BACTERIAL HAND GEL AND ANTI-BACTERIAL WIPES WILL BE PROVIDED BUT IS ADVISABLE TO BRING OWN ON THE DAY.

TO AVOID MINIMUM OF CROSS CONTAMINATION AND TO MINIMISE RISK TO THE COMMITTEE, THERE WILL BE NO CLUB SHOP OR RAFFLE AVAILABLE AT THIS SHOW.

CATALOGUES WILL BE BY PRE-ORDER ONLY, AND SET-OUT FOR COLLECTION ON A TABLE, WHICH WILL BE AWAY FROM THE ROSETTE & PRIZE CARD TABLE TO ENSURE THAT NO PINCH POINTS OR CONGREGATING AREAS ARISE.

SHOW SECRETARY TO KEEP A RECORD OF ALL THOSE IN ATTENDANCE, WHICH CAN BE DONE BY MEANS OF THE CATALOGUE AND ANY ADDITIONAL SPECTATORS WILL BE ASKED FOR THEIR DETAILS, WHICH WILL BE STORED TOGETHER WITH THE SHOW RECORDS.

ENTRANCE AND EXIT TO SHOW

THERE WILL BE STRICTLY ONE ENTRANCE AND ONE EXIT TO THE SHOW TO MINIMISE THE RISK OF PEOPLE CROSSING IN DOOR AND HALLWAYS. EXHIBITORS WILL BE ASKED TO BE PATIENT AND ENSURE THAT THEY MAINTAIN THE REQUIRED 1 METRE DISTANCE.

ANTI-BACTERIAL HAND GEL TO BE PLACED AT ENTRANCE AND EXIT, AND EVERYONES TEMPERATURE TO BE TAKEN ON ARRIVAL.

PARKING

MEMBER OF THE COMMITTEE TO BE AVAILABLE FOR PEOPLE ARRIVING, AND TO ADVISE TO PARK VEHICLES AT LEAST 1 METRE APART AND TO EXHBITORS TO BE ADVISED TO MAINTAIN SOCIAL DISTANCING WHEN UNLOADING AND LOADING DOGS IN CARS.

It is also advised as per Government Guidelines that anyone classed as vulnerable, or has shown symptoms or lives in the same household of anyone that has shown symptoms of the virus DOES NOT attend the show: -

Those classed as vulnerable are: -

- Clinically extremely vulnerable individuals (see definition below) have been strongly advised not to work outside the home (CEV).
 - Solid organ transplant recipients
 - People with specific cancers
 - People with cancer who are undergoing active chemotherapy
 - People with lung cancer who are undergoing radical radiotherapy
 - People with cancers of the blood or bone marrow such as leukaemia, lymphoma or myeloma who are at any stage of treatment
 - People having immunotherapy or other continuing antibody treatments for cancer
 - People having other targeted cancer treatments which can affect the immune system, such as protein kinase inhibitors or PARP inhibitors
 - People who have had bone marrow or stem cell transplants in the last 6 months, or who are still taking immunosuppression drugs
 - People with severe respiratory conditions including all cystic fibrosis, severe asthma and severe chronic obstructive pulmonary (COPD).
 - People with rare diseases that significantly increase the risk of infections (such as SCID, homozygous sickle cell).
 - People on immunosuppression therapies sufficient to significantly increase risk of infection.
 - Women who are pregnant with significant heart disease, congenital or acquired.
 - People who fall in this group should have been contacted to tell them they are clinically extremely
- Clinically vulnerable individuals, who are at higher risk of severe illness (for example, people with some pre-existing conditions, see definition below), have been asked to take extra care in observing social distancing and should be helped to work from home, either in their current role or in an alternative role (CVI).
 - Clinically vulnerable people include those aged 70 or over and those with some underlying health conditions, all members of this group are listed as 'clinically vulnerable'.
 - Aged 70 or older (regardless of medical conditions)
 - Under 70 with an underlying health condition listed below (that is, anyone instructed to get a flu jab as an adult each year on medical grounds):
 - Chronic (long-term) mild to moderate respiratory diseases, such as asthma, chronic obstructive pulmonary disease (COPD), emphysema or bronchitis
 - Chronic heart disease, such as heart failure
 - Chronic kidney disease
 - Chronic liver disease, such as hepatitis
 - Chronic neurological conditions, such as Parkinson's disease, motor neurone disease, multiple sclerosis (MS), or cerebral palsy
 - Diabetes
 - Weakened immune system as the result of conditions such as HIV and AIDS, or medicines such as steroid tablets
 - Being seriously overweight (a body mass index (BMI) of 40 or above)
 - Pregnant women

- If clinically vulnerable (but not extremely clinically vulnerable) individuals cannot work from home, they should be offered the option of the safest available on-site roles, enabling them to stay 2m away from others. If they have to spend time within 2m of others, you should carefully assess whether this involves an acceptable level of risk. As for any workplace risk you must take into account specific duties to those with protected characteristics, including, for example, expectant mothers who are, as always, entitled to suspension on full pay if suitable roles cannot be found. Particular attention should also be paid to people who live with clinically extremely vulnerable individuals.
